- A. All applicants must be present on the date this application will be considered by the Board of Selectmen.
- B. All applicants must secure liquor liability insurance for activities that will be conducted in or on town buildings property. Applicants seeking a license for activities to be held on private property are strongly urged to obtain liquor liability insurance.
- C. All special liquor licenses are subject to revocation by the Board of Selectmen, without notice, when it is deemed to be in the interest of the Town.
- D. All applicants for a special liquor license must be filed with the Board of Selectmen at least three weeks prior to the date requested by the applicant to be considered.
- E. Application fee of \$10.00 must be included with application.
- F. The Board of Selectmen reserves the sole right to accept or reject any application when it is deemed to be in the best interest of the Town.
- G. All applicants must be at least 21 years of age when making application for a special liquor license.
- H. All parties that are issued a special liquor license shall understand that they are obligated to observe all relevant Town bylaws and all applicable state statutes in regard to the use of this license.
